#### 3. Chairman's Report

#### Coll Mausoleum

Nicholas reported very briefly that funding for the Coll Mausoleum from the HLF's Nadir project had been rejected. He was however going to continue in his efforts to gain additional justifications so that a resubmission for funding can be made and consideration given to future action. Lachlan added that any hopes of funding from Historic Scotland would not be forthcoming until the year 2004.

#### 4. Treasurer's Report.

The Treasurer presented copies of the financial statement as at the 9th January 2000 showing a £3,088.31 net total of income over expenditure. James went on to express concern that current Covenants/Donations are raising only some £400 p.a. He again stressed that a considerable effort was required by all at the meeting to improve the Trusts cashflow.

Sir Lachlan said that he would be at the London Gathering on the 4th February and would raise the subject of funding for the Trust in his introductory speech to the London Branch members and their guests.

Donald suggested that now we have identified the Inverkeithing project for 2001, then this project should as a priority be put onto the existing Maclean inter-net web site. To support this approach Nicholas was asked to provide a suitable "sharp and exciting" write up of the battle. Additionally Allan was asked if he would undertake to map out the scene of the battle and pass the results of his labours to Donald by Mid February for inclusion onto the web page.

Donald also asked that a prospective list of affluent names for fund-raising be compiled, bearing in mind such persons do not need to bear the Maclean name. It may transpire that other affluent persons with Scottish interests of a business or personal nature might be sympathetic to the Trusts ambitions.

#### 5. Project Reports.

#### 5.1 Inverkeithing 1651

Sir Lachlan stated that a suitable site now appears to have been found and discussions are to take place with Sandy Mason of Alfred Stewart Properties on the erection of a suitable monument. The hope was that a cairn would be built in a similar style to the one placed on Islay.

#### 5.2 Iona - Maclean's Brass Foot

Allan reported that the achievement of this project was under control.

#### 5.3 Coll Mausoleum

Held in abeyance. (See comments under Item 3 Chairman's Report.)

#### 5.4 Genealogical Project

In this area Allan was asked to collect evidence on what was currently being undertaken in the area of Family History and to put forward, if possible, some tentative proposals for consideration. It was felt that at the next gathering the printing and updating of Family History Charts could be a possible fund raiser for the Heritage Trust.

#### 5.5 Register of Deeds

The Chairman reported that due to cost this project is unlikely to be undertaken at the present time by the Scottish Record Office (SRO). [After the meeting NMB and AMM visited SRO and discussed possibility of AMM carrying out this task.] Report to be given at next meeting.

#### 5.6 Maclean Piper Bursary

Donald was still working on this in terms of considering whether or not it should be a Home or Overseas young piper who should be supported. It has come to light that there are one or two young home grown Maclean pipers who might be more than capable of fulfilling the bursary standards. The result of the Home/Overseas debate would of course have an influence on the travel and accommodation costs to be borne by the Trust for the Piping Course.

#### 5.7 Maclean Pipe Music Reprint

Currently being actioned by Donald with the intention of the reprints being available by the 2002 gathering.

#### 5.8 Lichlee Battle of Mull

Sir Lachlan said that the only person who could identify the site of this battle between Macleans and MacDonalds (1580) was Lachlan Maclean of Knock. It was again thought to be advantageous to the Heritage Trust if this project could be finalised prior to 2002.

#### 5.10 Pennycross Graveyard

Allan volunteered to ask WeldMech at Taynuilt to provide cost estimates for the replacement of decorative axe-heads missing from the railings when next a Company representative was on Mull.
