5. Project Reports.

5.1 Inverkeithing 1651

There had been a visit to the area of the battle during the morning of this meeting and it is hoped that a cairn and plaque can be sited near to the spot where Hector was alleged to have finally fell. Sir Lachlan will continue to liaise with Fife Enterprise in an effort to firm up on the site location. Lachlan pointed out that help would be needed, under his guidance, to act as a Site Manager when materials were delivered and the building of the cairn got under way. On this last point Allen said that he had in mind people who had experience in such matters and he would ask them to assist.

The cairn is to be similar to the one at Drimin with the inscription in both English and Gaelic. Allan was asked to put forward a draft paper on how the Ceremony on the day should be undertaken and Nicholas undertook to create a Battle Site Plan which could be erected close to the cairn to offer a better understanding of what happened during the day.

Allan also suggested that a leaflet giving the background to the Battle of Inverkeithing would express the educational aims of the Trust.
