# MINUTES OF THE 19th MEETING Held at The Western Club, Glasgow at 12.30pm on the 10th March 2004

2. Minutes of the 18th Meeting: Accepted by all present.

3. Chairman's Remarks: The Chairman welcomed Marcus as a trustee in his capacity as President of the Clan Maclean Association in succession to Donald.

3.1 Matters Arising from the Minutes:

a. Pennycross Papers

Allan had heard from Janet Grant who explained that the papers had been given to Nicholas Maclean of Pennycross. Nicholas in return said that he had nothing. There is nothing further we can do.

b. Sir Lachlan Maclean's gravesite at Kilchoman

No reply to Allan's letter to the Session Clerk in Isley. Allan to chase with further letter to the Session Clerk with a copy to Robin Curry. Dr James was asked to obtain the name of the Clerk in Islay.

c. Boreray Mausoleum

**4.** Trustee Appointments Lachlan has appointed Ian MacLean, Nova Scotia as his trustee, and Prof Ephraim McLean, Atlanta, has agreed to be a co-opted trustee. Allan welcomed the new trustees and look forward to receiving their ideas. Mac to scan the Trust Deed for Ian and Ephraim.

#### 5. Finances:

#### a. Current Position

The Treasurer at the meeting gave the balance on the account as £3,160 + £1,424.

#### b. Duart Gathering Wedding

The promised donation has not yet been received.

#### c. Donation from Western Australia.

A donation had been received of £50 from W.A. Mac was asked to acknowledge by letter.

#### d. Other Donation.

Allan to write to the Skelton family thanking them for their donation.

#### 6. Books and Archive.

#### a. National Archives of Scotland.

Allan had met with a Dr. David Brown at the National Archives and had discussed the 4 older charters, one of which needs conservation and then can be copied along with the other three. The trust are to supply the paper and inks required for the conservation task.

#### b. Papers at Mull Museum.

The Museum still await the database of papers from Allan.

Allan had been talking to the widow of the Highland historian, R W Munro, who had specialised in Macquarrie genealogy. Apparently his widow is looking for a place to deposit his papers and card index. Allan has suggested the Isle of Mull Museum probably via the CMHT.

7. Genealogy:

Allan stated that he had not moved very much further with this problem since he cannot access Maclean web. Marigold however is moving forward on the amalgamation of all Australian Maclean records.

#### 8. Friends of CMHT:

a. Chairman's Report for 2003.

Mac asked the meeting if the idea of the Heritage Trust having it's own flag or banner was a possibility or not. The consensus at the meeting was that it was not a requirement.

#### b. Trigh Gruinneart Large Display.

Trustees were concerned to hear such news, and requested Mac to write and seek clarification from the Royal Society for the Protection of Birds (RSPB) about the reported removal of the display.

Colonel Ellis the current owner of the house is to be contacted by the Chief in order to gain approval for a plaque to record the visit by Johnson and Boswell to the then home of Dr Hector Maclean of Gruline
